



Good Neighbor Award Rules and Eligibility Criteria

Eligibility Criteria

1. If a nominee was a previous IR Good Neighbor Award Winner, they will not be eligible to be an applicant again no matter the length of years since previously winning.
2. Nominees must be members of Idaho REALTORS® in good standing.
3. Nominees should have made a significant impact as a volunteer for a nonprofit organization. Eligible activities are not limited to real estate or housing issues.
4. Nominees should have made a significant contribution of personal time, but contributions of money, materials, and other resources will also be considered by the judges.
5. Nominees will be judged on level of personal contribution, impact of personal contribution, and broadness of impact.
6. The award is intended to recognize individual contributions, not association- or company-wide efforts. If an individual within your company can be singled out as instrumental to the success of a group effort, he or she is eligible. If the achievements of two people (such as a married couple or co-founders of an organization) cannot be separated, they can enter as a pair and their entry will be considered as one.
7. Some portion of the nominee's community work must have taken place during the timeframe specified on the application form, but judges will also consider ongoing efforts outside that timeframe that demonstrate a depth of commitment.
8. Nominees should be able to document the results of their individual involvement through published reports and/or testimonials from the organization they served or the people they helped.
9. Nominations must be accompanied by a completed entry form to be considered (REALTORS® may nominate themselves or may be nominated by another member, a local association executive, or the

Good Neighbor Awards Program Rules

1. Nominees must be members in good standing of Idaho REALTORS®.
2. To enter or nominate a REALTOR®, complete the official entry form and submit it with attachments.
3. Entries must be received by 5 PM MT on the deadline date to be considered for that calendar year's awards. All entries shall become the property of Idaho REALTORS® and will not be returned. Visit our nomination page at Idahorealtors.com to learn more. Finalists will be nominated by the Idaho REALTORS® Executive Committee.



4. The finalists' nomination materials will be sent to a panel of judges appointed by the IR Executive Committee for scoring. Judges will award points to finalists' entries based on level of personal contribution, impact of personal contribution, and the nominee's suitability as a role model for other REALTORS®. The judges' decisions, including selecting a winner from the nominees, are final.
5. Nominees' entry information will not be given to anyone outside of the Idaho REALTORS® Executive Committee, IR staff and the judges; judges will receive only the information necessary to evaluate a nominee.
6. A monetary prize in the amount of \$1,500 may be awarded by Idaho REALTORS® to the nonprofit named by the nominee selected by the judges as the winner of award.
7. The staff of IR and the program sponsors will not take phone calls or release any information regarding the judges' identities, judging process, or status of the entries.
8. Finalists must sign an affidavit of eligibility and be willing to be interviewed, photographed, filmed, and featured by IR.
9. Good Neighbor judges and their families, IR staff, program sponsors, and their families are ineligible to participate.
10. Idaho REALTORS®, program sponsors and judges are not responsible for late, stolen, or misdirected entries. The winner will be notified by telephone or email.
